## **CITY OF ATLANTIC BEACH LAND DEVELOPMENT REGULATIONS UPDATE**

### **What are Land Development Regulations?**

The Land Development Regulations implement the Vision, Goals, Objectives and Policies of the City's Comprehensive Plan which affects the quality of life in through policies, projects and programs. The Land Development Regulations include zoning standards, subdivision regulations and requirements for natural resource protection. The Land Development Regulations are tied to the Official Zoning Map which separates the land into districts, defines permitted, conditional and special uses and specifies things such as density, lot coverage, open space, impervious surface limits, landscaping, parking & loading requirements.

### **Why is the City updating the Land Development Regulations?**

The City is updating (or re-writing) its Land Development Regulations because the Elected Officials and staff recognize that it is not functioning at its best to serve you, the citizens and business owners. Our goal is to provide you with a document that is user-friendly, effective to navigate with regulations that achieve the City's development goals. Some examples include the amount of impervious area on lots that prohibits drainage; number of required parking spaces for commercial uses (a more urban standard, versus suburban), compatibility of housing sizes/context; clarification of platting requirements; improved definitions; clarification within the environmental/wetlands section; and overall ease of use/reference.

### **Who will lead the Land Development Regulations Update process?**

The Northeast Florida Regional Council in conjunction with Kimley-Horn will be coordinating the Land Development Regulation Update process. Kimley-Horn and the Northeast Florida Regional Council will work hand in hand with the City Planning staff to complete this project. Input from citizens, the business community and other governmental agencies is needed to ensure that issues are identified and solutions are built into the update Land Development Regulations.

### **Where can I view the current Land Development Regulations?**
